

MEMORANDUM
on mutual cooperation between

Aktobe Regional University named after K. Zhubanov (hereinafter "University") represented by a **Member of the Management Board, Vice - rector for Science and Innovation Beknazarov Rakhym Agibayevich** and **" Chisty Sled "LLP** (hereinafter referred to as the " Company"), represented by **General Director Baymukashev Aynash Rashidkyzy**, in order to strengthen joint cooperation, have concluded this memorandum of cooperation (hereinafter referred to as the Memorandum).

1. SUBJECT OF THE MEMORANDUM

1.1 The parties undertake to create a system of partnership relations, within the framework of which they organize and develop long-term, effective and mutually beneficial cooperation in the field of ecology, sorting, recycling and processing with further production using secondary raw materials (MSW), as well as interaction in order to meet the needs for qualified personnel.

1.2 The Parties exchange information on the issues stipulated by this Agreement, hold mutual professional consultations and joint working meetings, and develop common solutions in areas of cooperation.

1.3 To solve and implement certain tasks of this Agreement, the Parties may create working groups.

2. MAIN AREAS OF COOPERATION BETWEEN THE PARTIES

2.1 The company conducts seminars aimed at improving the competencies of both students and teachers. Joint organization of round tables, seminars, scientific and practical conferences for the exchange of experience in the field of ecology, sorting, recycling and processing with further production using secondary raw materials (MSW).

2.2 The Company has the right to select personnel from among University graduates.

2.3 The university engages employees of the company in the development of a modular educational program at the bachelor's and master's levels in accordance with the profile of the educational program and takes into account the interests of the Company.

2.4 Проводятся Joint scientific research is carried out in the direction of the Company's activities.

2.5 Students of the University undergo a professional internship on the basis of the Company in accordance with the profile of the educational program.

2.6 The parties participate in the development of joint topics and directions for the preparation of diploma projects, master 's theses, and

joint projects.

2.6 Other forms of cooperation within the competence of the Parties

3. OTHER CONDITIONS

3.1. This Memorandum is concluded for an indefinite period. The Memorandum may be terminated by unilateral termination.

3.2. If one of the Parties declares its desire to terminate this Memorandum, it is necessary to notify the other Party in writing no later than 15 (fifteen) calendar days before the expected date of termination, after which the Memorandum is considered terminated.

3.3. All amendments and additions to this Memorandum must be made in writing and signed by the Parties.

3.4. This Memorandum comes into force from the date of its signing by both Parties.

3.5. This Memorandum is drawn up in two copies, in the Russian language, having equal validity.
