

MEMORANDUM
ON MUTUAL COOPERATION BETWEEN
NJC"AKTOBE REGIONAL UNIVERSITY NAMED AFTER K.

JSC " SOCIAL AND ENTREPRENEURIAL CORPORATION

NAO " Aktobe Regional University named after K. Zhubanov " (hereinafter "University") represented by the Chairman of the Management Board-Rector Laura Chapayevna Karabasova, acting on the basis of the Charter, on the other hand , and **JSC "Social and Entrepreneurial Corporation " Aktobe "** (hereinafter referred to as "The Organization"), represented by Chairman of the Management Board of the Organization Kairatov Bauyrzhan Kairatovich, collectively referred to as the Parties, in order to strengthen joint cooperation, have concluded this Memorandum on the following:

1. SUBJECT OF THE MEMORANDUM:

1.1. The parties undertake to create a system of partnership relations, within the framework of which they organize and develop long-term, effective and mutually beneficial cooperation in the development of scientific research, academic exchange, implementation of joint projects, as well as interaction in order to meet the needs for qualified personnel;

1.2. The Parties shall exchange information on the issues stipulated by the Agreement of the Parties.

this Memorandum, conduct mutual professional consultations and joint working meetings and develop common solutions in areas of cooperation;

1.3. The Parties may set up working groups to solve and implement certain tasks of this Memorandum.

2. MAIN AREAS OF COOPERATION BETWEEN THE PARTIES

Within the framework of this Memorandum, the Parties agreed to take joint actions to solve the following tasks:

2.1. conducting joint research, submitting applications for grant financing projects of the Ministry of Foreign Affairs of the Republic of Kazakhstan, international projects, commercialization projects;

2.2. assist in the promotion and implementation of unique scientific, business and social projects;

2.3. improving the entrepreneurial potential of the University's teaching staff , identifying and overcoming existing challenges

barriers to the development of entrepreneurship and commercialization of the results of scientific and (or) scientific and technical activities (hereinafter referred to as RNNTD);

24. Creating a favorable environment for attracting investment and introducing innovations, as well as conditions for the development of small and medium-sized businesses in the University;

25. creating a positive image of the Parties for the Kazakh investment community;

26. interaction with public organizations and the expert community;

27. The organization has the right to select personnel from among University graduates;

28. The University, in agreement with the Organization, engages employees of the organization in the development of a modular educational program at the bachelor's and master's levels in accordance with the profile of the educational program and takes into account the interests of the Organization;

29. The parties take an active part in organizing and conducting joint events, seminars, master classes, trainings, etc.;

2.10. The parties, by agreement, participate in the development of joint development and technical works and grant projects.

2.11. Assistance in finding co-financiers (investors) for business projects of the university for further participation in grant financing of commercialization of scientific projects.

3. FORMS OF INTERACTION

3.1. Exchange of information (by sending messages between the Parties, organizing meetings of representatives of the Parties, etc.) related to the field of cooperation;

3.2. Consultations on issues related to the activities of the Parties and of mutual interest;

3.3. Planning of joint activities (development of programs) aimed at achieving the objectives of this Memorandum;

3.4. Joint development of priority innovation projects and creation of conditions for the implementation of the created innovative technologies and products;

3.5. Creation and maintenance of joint commissions, committees, working groups, other advisory, expert and other bodies;

3.6. Conclusion of contracts (agreements) aimed at achieving the goals of cooperation between the Parties.

4. FINAL PROVISIONS

4.1. This Memorandum shall be valid for three (3) years;

4.2. All amendments and additions to this Memorandum must be made in writing and signed by the Parties;

- 4.3. If one of the Parties declares its desire to terminate this Memorandum, it is necessary to notify the other Party in writing no later than 30 calendar days in advance;
- 4.4. This Memorandum is drawn up in two copies in the Russian language.
