## MEMORANDUM on mutual cooperation between NJC ''Aktobe Regional University named after K. Zhubanov'' and "Kazenergomashecology" LLP

Non-Profit Joint Stock Company "Aktobe Regional University named after K. Zhubanov" (hereinafter referred to as the "University"), represented by the Member of the Board – Vice-Rector for Science and Innovation, Mr. Rakhym Agibayevich Beknazarov, acting on the basis of Order No. 636-N dated September 1, 2022 and the Power of Attorney, on the one hand, and LLP "KazEnergoMashEcology" (hereinafter referred to as the "Organization"), represented by Director Mr. Dauren Muratovich Kazmangbetov, on the other hand, collectively referred to as the "Parties", hereby enter into this Agreement for the purpose of strengthening mutual cooperation as follows:

# **1. SUBJECT OF THE AGREEMENT**

1.1. The Parties undertake to establish a partnership system through which they will organize and develop long-term, effective, and mutually beneficial cooperation in the areas of scientific research, academic exchange, environmental protection, and meeting the demand for qualified specialists.

1.2. The Parties shall exchange information on matters covered by this Agreement, hold joint professional consultations and working meetings, and develop joint solutions in the fields of cooperation.

The Parties may establish working groups to address and implement specific objectives of this Agreement.

## 2. MAIN AREAS OF COOPERATION

2.1. The Parties shall conduct joint scientific research, submit grant project applications to the Ministry of Science and Higher Education of the Republic of Kazakhstan, as well as to international and commercialization projects.

2.2. The Parties shall jointly publish scientific articles and patents.

2.3. For the purpose of conducting scientific research, the Parties shall jointly use laboratories and equipment.

2.4. The Organization shall conduct seminars to enhance the competencies of students and faculty in the field of environmental protection, not only in terms of emission source inventory and sanitary zone calculations, but also to provide hands-on skills in the design and calculation of gas-cleaning equipment.

2.5. The Organization reserves the right to recruit University graduates.

2.6. The University shall involve employees of the Organization in the development of modular educational programs at the undergraduate and graduate levels, aligning with the educational program's profile and the interests of the Company.

2.7. University students shall undertake professional internships at the Organization in accordance with the profile of their educational programs.

2.8. The Parties shall jointly develop topics and areas for diploma projects, master's theses, joint scientific research, R&D, contractual, and grant-based projects.

# **3. ADDITIONAL PROVISIONS**

3.1. This Agreement shall remain in force for a period of three (3) years.

3.2. The Parties shall notify each other of any changes to their contact or banking details no later than ten (10) days from the date such changes occur.

3.3. Any amendments and additions to this Agreement must be made in writing and signed by both Parties.

3.4. If either Party wishes to terminate this Agreement, it must notify the other Party in writing at least two (2) months in advance.

3.5. This Agreement is drawn up in two copies in Russian, each having equal legal force.
