

MEMORANDUM ON
MUTUALCOOPERATION
between
AKTOBE REGIONAL UNIVERSITY NAMED AFTER K. ZHUBANOV and
TC PHARM AKTOBE LLP

NAO " K. Zhubanov Aktobe Regional University "(hereinafter referred to as the "University") represented by the Chairman of the Management Board-Rector Laura Chapayevna Karabasova, acting on the basis of the Charter, on the other hand, and TC Pharm Aktobe LLP (hereinafter referred to as the "Organization"), represented by Director Zhanagul Turekhanova collectively referred to as the Parties, in order to strengthen joint cooperation, have concluded this Memorandum on the following:

1. SUBJECT OF THE MEMORANDUM

- 1.1. The parties undertake to create a system of partnership relations, within the framework of which they organize and develop long-term, effective and mutually beneficial cooperation in the development of scientific research, academic exchange and ecology, as well as interaction to meet the needs for qualified personnel.
- 1.2. The Parties exchange information on the issues stipulated in this Memorandum, hold mutual professional consultations and joint working meetings, and develop common solutions in areas of cooperation.
- 1.3. The Parties may set up working groups to solve and implement certain tasks of this Memorandum.

2. MAIN AREAS OF COOPERATION BETWEEN THE PARTIES

- 2.1. The parties conduct joint scientific research, submit applications for grant funding from the Ministry of Science and Higher Education of the Republic of Kazakhstan, international projects, commercialization projects.
- 2.2. The parties jointly publish articles and patents.
- 2.3. The organization has the right to select personnel from among University graduates.
- 2.4. The University, in agreement with the Organization, engages employees of the organization in the development of a modular educational program at the bachelor's and master's levels in accordance with the profile of the educational program and takes into account the interests of the Organization.
- 2.5. Students, with the agreement of the University and the Organization, undertake professional internships at the Organization in accordance with the profile of the educational program.

2.6. The parties, by agreement, participate in the development of joint topics and directions for the preparation of diploma projects, master's theses, joint research works, scientific research projects, etc.

FINAL PROVISIONS

- 3.1. This Memorandum is valid for three (3) years.
- 3.2. All amendments and additions to this Memorandum must be made in writing and signed by the parties.
- 3.3. If one of the Parties declares its desire to terminate this Memorandum, it is necessary to notify the other Party in writing no later than 30 calendar days in advance.
- 3.4. This Memorandum is drawn up in two copies in Russian.
